You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:

EMTN in the form of Limited Recourse Notes.

Objectives:

The Guaranteed EMTN Stork DMS 3Y 75% 10/2021 is a CPPI Linked Note which return is determined by the performance of a reference portfolio managed through a method referred to as Constant Proportion Portfolio Insurance ("CPPI").

The CPPI is a dynamic allocation mechanism which apportions the Series Assets backing CPPI Linked Notes, between a performance component in the form of Reference Assets (A Share of Stork Fund – Dynamic Multi-Strategies) and a risk-free component in the form of a Reference Bond, based on their relative performance. The Reference Bond reflects the value allocated for protection by the Investment Manager to ensure payment at maturity of the Protected Amount to

Noteholders.

This product was launched in 2018.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

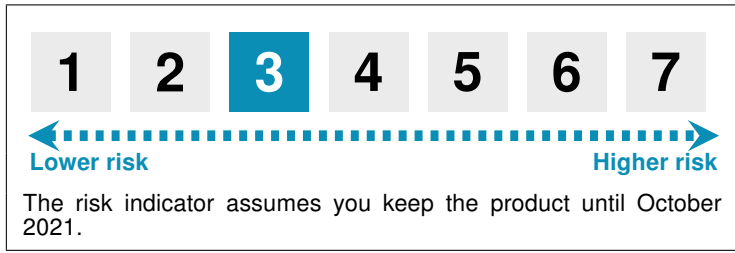

What are the risks and what could I get in return?

Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

What happens if Cigogne Management S.A. is unable to pay out?

What are the costs?

Costs over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10000 EUR. The figures are estimates and may change in the future.
