You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:

EMTN in the form of Limited Recourse Notes.

Objectives:

The Guaranteed EMTN Stork DMS 12Y 100% 01/2030 is a CPPI Linked Note which return is determined by the performance of a reference portfolio managed through a method referred to as Constant Proportion Portfolio Insurance ("CPPI").

The CPPI is a dynamic allocation mechanism which apportions the Series Assets backing CPPI Linked Notes, between a performance component in the form of Reference Assets (A Share of Stork Fund – Dynamic Multi-Strategies) and a risk-free component in the form of a Reference Bond, based on their relative performance. The Reference Bond reflects the value allocated for protection by the Investment Manager to ensure payment at maturity of the Protected Amount to

Noteholders.

This product was launched in 2018.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

Intended retail investor: This product is intended for retail and professional investors.

Term of product:

The product will mature on January 2030.

Risk indicator:



The risk indicator assumes you keep the product until January 2030.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The product is also exposed to the following materially relevant risks that are not included in the summary risk indicator:

You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

Costs over time
