You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: EMTN in the form of Limited Recourse Notes.

The EMTN Stork DMS 12/2022 is a Fund Linked Notes with coupon indexed on the performance of A Share of Stork Fund - Dynamic Multi-Strategies (the underlying fund).

This product was launched in 2012.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

Intended retail investor:

This product is intended for retail, well-informed and professional investors. Luxembourg and Belgium only.

Term of product:

The product will mature on December 2022.

What are the risks and what could I get in return?

Risk indicator:



The risk indicator assumes you keep the product until December 2022.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Costs over time
