### What is this product?

#### Type:

EMTN in the form of Limited Recourse Notes.

This product is a capitalisation product meaning that income and capital gains are reinvested.

#### Objectives:

The EMTN Stork DMS 0.25% 31/10/2029 is a Fund Linked Notes with coupon indexed on the performance of A Share of Stork Fund - Dynamic Multi-Strategies (the underlying fund).

#### Intended retail investor:

This product is intended for Belgium consumers.

This product was launched in 2019.

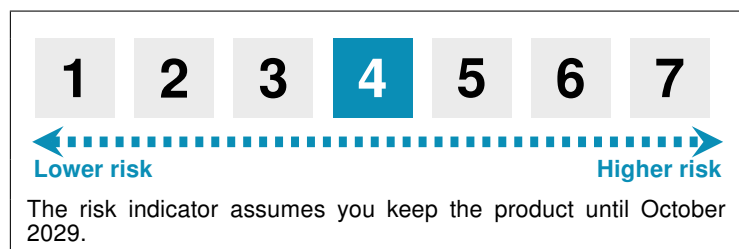
#### Term of product:

The product will mature on October 2029.

The currency of the product is expressed in EUR.

## What are the risks and what could I get in return?

### Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

## What happens if Stork Acceptance S.A. is unable to pay out?

### Costs over time
