You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:

EMTN in the form of Limited Recourse Notes.

Objectives:

The "Guaranteed EMTN Stork DMS 5Y 75% 05/2025" is a CPPI Linked Note which return is determined by the performance of a reference portfolio managed through a method referred to as Constant Proportion Portfolio Insurance ("CPPI").

The CPPI is a dynamic allocation mechanism which apportions the Series Assets backing CPPI Linked Notes, between a performance component in the form of Reference Assets (A Share of Stork Fund – Dynamic Multi-Strategies) and a risk-free component in the form of a Reference Bond, based on their relative performance. The Reference Bond reflects the value allocated for protection by the Investment Manager to ensure payment at maturity of the Protected Amount to

Noteholders.

This product was launched in 2020.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

Intended retail investor:

This product is intended for retail and professional investors. This product is not intended for Belgium consumers.

The product will mature on May 2025.

Costs over time
