You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The sub-fund is a compartment of the fund STORK FUND, the latter being a Luxembourg SICAV (Société d'Investissement à Capital Variable / Investment company with variable capital), qualifying as a specialised investment fund ("SIF") under the Law of 13 February 2007.

Term

This sub-fund has no maturity date. However, the sub-fund could be terminated under the conditions led down in the Prospectus and in the Articles of incorporation of STORK FUND.

Objectives

The investment objective of the sub-fund is to develop a dynamic approach to build a medium to high level risk/return portfolio.

The sub-fund is a fund of funds that focuses on UCIs (Alternative Investment Funds and UCITS), primarily but not limited to UCIs managed by Cigogne Management SA. Thenceforth the performance of the sub-fund should be evaluated in the absolute and not compared to a benchmark or market trends.

Portfolio diversification is obtained through a broad range of alternative strategies including, but not limited to ABS/MBS Arbitrage, CLO Arbitrage, Credit Arbitrage, Convertible Arbitrage, Fixed Income Arbitrage, Risk Arbitrage and other comparable strategies having an alternative approach to traditional investing consistent with the objective of the sub-fund.

If considered appropriate to the investment strategy or for defensive purposes, the sub-fund may, according to the principle of risk spreading, invest the assets not allocated to trading as described here above, in instruments listed hereafter such as transferable debt securities and/or money market instruments and/or hold cash.

The debt securities, in which the sub-fund may invest, comprise all kind of issuers without any minimum rating requirement.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is intended for well-informed, semi-professional (Germany) and professional investors.

Other information

Depository: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The product is also exposed to other risks that are not included in the summary risk indicator.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What happens if Cigogne Management S.A. is unable to pay out?

You may not face a financial loss due to the default of the Manufacturer. To protect you, the assets of the sub-fund are held in safekeeping by the Depositary. In the event of the insolvency of the Manufacturer, the sub-fund's assets in the safekeeping of the Depositary will not be affected, the investments will be liquidated and the proceeds will be distributed to the investors. In this case you could suffer a financial loss and, in the worst case, you could lose your entire investment. You are not covered by any national compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The recommended holding period is set to 3 years based on the Objectives of the sub-fund and the strategies implemented as described in the Prospectus. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on a monthly basis.
