You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

The sub-fund is a compartment of the fund, the latter being a Luxembourg Investment Fund (Fonds Commun de Placement), qualifying as a specialised investment fund ("SIF") under the Law of 13 February 2007.

Term

This sub-fund has no maturity date. However, the sub-fund could be terminated under the conditions led down in the Prospectus and in the Articles of incorporation of CIGOGNE FUND.

Objectives

The investment objective of CIGOGNE FUND - Fixed Income Arbitrage, is to realize consistently high risk-adjusted appreciation in the value of its assets.

The sub-fund will seek to achieve its investment objective by primarily using fixed income arbitrage strategies on US, European and Japanese listed bonds.

Fixed Income Arbitrage is the investment strategy is designed to profit from identifying mispricings between correlated bonds or OTC products such as swaps, interest rates options.

The sub-fund may invest in securities, warrants, bonds and other fixed-income securities. For the purpose of efficient portfolio management and for currency hedging in the context of the management of its assets and liabilities, the sub-fund may engage, with collateral if necessary, in options, futures, swaps, securities lending or borrowing and other derivative instruments or techniques, traded on an exchange or over-the-counter.

The debt securities in which the sub-fund invests include mainly public issuers but may include any type of issuer with no minimum rating restriction.

What happens if Cigogne Management S.A. is unable to pay out?

You may not face a financial loss due to the default of the Manufacturer. To protect you, the assets of the sub-fund are held in safekeeping by the Depositary. In the event of the insolvency of the Manufacturer, the sub-fund's assets in the safekeeping of the Depositary will not be affected, the investments will be liquidated and the proceeds will be distributed to the investors. In this case you could suffer a financial loss and, in the worst case, you could lose your entire investment. You are not covered by any national compensation or guarantee scheme.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The recommended holding period is set to 3 years based on the Objectives of the sub-fund and the strategies implemented as described in the Prospectus. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on a monthly basis.
