You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The sub-fund is a compartment of the fund CIGOGNE FUND, the latter being a Luxembourg Investment Fund (Fonds Commun de Placement), qualifying as a specialised investment fund ("SIF") under the Law of 13 February 2007.

Term

This sub-fund has no maturity date. However, the sub-fund could be terminated under the conditions led down in the Prospectus and in the Articles of incorporation of CIGOGNE FUND.

Objectives

The investment objective of CIGOGNE FUND - Credit Arbitrage, is to realize consistently high risk-adjusted appreciation in the value of its assets.

The sub-fund will seek to achieve its investment objective by primarily using strategies based on basis trades, credit curves trades, correlation products and on relative value arbitrage.

Strategies may be implemented on the following geographical areas: Europe, North America, and Asia. The sub-fund is allowed incidentally investments in other geographical areas.

The investment strategy is designed to profit from mispricing in spread on these products and consists of constructing a balanced portfolio of Interest Securities, tradeable CDS or credit indices and Interest derivatives, managing interest rate and default risks of these securities in order to extract the spreads they offer.

The sub-fund may invest in equities, bonds, credit indices (such as CDX, iTraxx), single name CDS, credit index tranches, options on credit instruments (such as CDS and credit index options) and any other similar financial instruments designed to transfer credit and correlation risk.

The sub-fund may also engage, with collateral if necessary, in securities lending/borrowing transactions as well as in options, futures and other derivative transactions, whether traded on an organised market or over-the-counter. The debt securities in which the sub-fund may invest include mainly private issuers

but may include any type of issuer without any minimum rating requirement.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is intended for well-informed and professional investors.

Other information

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units of one sub-fund into units of the same sub-fund or another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

What happens if Cigogne Management S.A. is unable to pay out?

You may not face a financial loss due to the default of the Manufacturer. To protect you, the assets of the sub-fund are held in safekeeping by the Depositary. In the event of the insolvency of the Manufacturer, the sub-fund's assets in the safekeeping of the Depositary will not be affected, the investments will be liquidated and the proceeds will be distributed to the investors. In this case you could suffer a financial loss and, in the worst case, you could lose your entire investment. You are not covered by any national compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The recommended holding period is set to 3 years based on the Objectives of the sub-fund and the strategies implemented as described in the Prospectus. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on a monthly basis.
